NOTICE OF VACANCIES

The National Environment Cleaning Authority invites applications from suitably qualified candidates who wish to be considered for appointment for the following posts:

- (A) Office Attendant
- (B) Driver
- (C) Gardener / Nursery Attendant
- (D) General Worker

II. AGE LIMIT

For the above posts, candidates should not be above <u>48 years</u> of age unless already in service in the Public Sector by the closing date of submission of applications.

III. For post (A) - Office Attendant

(i) **QUALIFICATIONS**

A Cambridge School Certificate or have obtained passes on one certificate at the General Certificate of Education "Ordinary Level" either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject or an equivalent qualification acceptable to the Board of the National Environment Cleaning Authority.

For post (B) – Driver

- (ii) possess a valid driving licence (manual gear) to drive cars or vans or minibuses or lorries up to five tons;
- (iii) have a basic knowledge of mechanics and simple maintenance; and
- (iv) have good eyesight.
