NOTICE OF VACANCIES

The National Environment Cleaning Authority invites applications from suitably qualified candidates who wish to be considered for appointment for the following posts:

- (A) General Worker
- (B) Gardener/Nursery Attendant

I. <u>AGE LIMIT</u>

For the above posts, candidates should not be above <u>48 years</u> of age unless already in service in the Public Sector by the closing date of submission of applications.

II. For post (A) – General Worker

(i) **QUALIFICATIONS**

- (a) Candidates should:
 - (i) possess the Certificate of Primary Education or the Primary School Achievement Certificate;

In the absence of candidates not possessing the Certificate of Primary Education or the Primary School Achievement Certificate, consideration will be given to candidates who have studied up to Standard 6/Grade 6 or equivalent.

(ii) SALARY SCALE

Rs 10,250 x 175 - 10,775 x 200 - 11,775 x 205 - 12,595 x 230 - 13,975 x 250 - 15,225 x 260 - 17,825 x 275 - 18,925 x 300 - 19,525 x 325 - 21,150

For post (B) – Gardener / Nursery Attendant

(i) **QUALIFICATIONS**

- (a) Candidates should:
 - (i) possess the Certificate of Primary Education or the Primary School Achievement Certificate; and
 - (ii) reckon at least three years' experience in gardening and nursery techniques.

In the absence of candidates not possessing the Certificate of Primary Education or the Primary School Achievement Certificate, consideration will be given to candidates who have studied up to Standard 6/Grade 6 or equivalent.

(ii) SALARY SCALE

Rs 14,725 x 250 - 15,225 x 260 - 17,825 x 275 - 18,925 x 300 - 19,525 x 325 - 21,475 x 375 - 22,225 x 400 - 23,425 x 525 - 23,950

NOTE:

All eligible employees to be recruited by NECA would be paid the **National Minimum Wage** approved by the Government as from *January 2024* and amounting to **Rs 16,500.00** (inclusive of salary compensation 2024).

These employees would also benefit from a **Special Allowance** of **Rs 2000.00** from the Mauritius Revenue Authority.
